#### Information about our organization and website

### **Collection, Use and Retention of Personal Information**

Castrol has requested your name, job title and email address for the purpose of granting you access to this site and setting up your account for projects you are involved into. Collection of this information is based on Castrol's legitimate interest in enabling its employees, service providers, customers and relevant stakeholders to efficiently manage and follow a Marine or Energy project through this global platform. We will retain your personal information for as long as it is needed for managing projects, and we will automatically delete any information which relates to you within the period of 90 days after your relationship with projects or Castrol ends or delete it immediately on your request to support team.

#### **Disclosures and Transfers of Personal Information**

Castrol does not sell or otherwise release your personal information to third parties to allow them to direct market their products and services to you. We may need to share your personal information with third party service providers that process data on our behalf; however any third party we appoint must only act in accordance with our written instructions when processing your personal data, in line with contractually required security measures.

Since Castrol operates globally, Castrol may want to transfer your personal information to other countries, including countries outside the European Economic Area (EEA). Where this is the case, we do this under our group-wide Binding Corporate Rules, which guarantee an adequate level of data protection wherever your data is physically kept.

We reserve the right to disclose your personal information as required by law, or when we believe that disclosure is necessary to protect our rights and/or comply with a judicial proceeding, court order, request from a regulator or any other legal process served on Castrol. In the event that Castrol is subject to a takeover, divestment or acquisition we may disclose your personal information to the new owner of the business.
